That the Mayor and City Clerk be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, a copy of which is on file in the office of the City Clerk as Document No. 766931, conveying to THE SIGNAL COMPANIES, INC., a Delaware corporation, Lot 15, Torrey Pines Science Park Unit No. 3, as more particularly described in said grant deed, for the sum of Nine Hundred Twenty-Seven Thousand Dollars (\$927,000).
- 3. That a broker's commission in the amount of Twenty-Five Thousand Six Hundred Seventy-Five Dollars (\$25,675) shall be paid by The City of San Diego in the herein described sale.
- 4. That the payment of related expenses in connection with the sale from the proceeds thereof is hereby authorized.
- 5. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Department for further handling.
