


RESOLUTION No. 224091 (R-80-134)

Adopted on JUL 24 1979

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an amended agreement with NATIONAL SEMICONDUCTOR CORPORATION ("National") providing for the completion of the grading, landscaping and irrigation of the Campus Point Subdivision by National; terminating the escrow for the sale of a portion of the property and returning their deposit of \$294,000; providing for an extended reimbursement of those costs incurred by National which directly improve the subdivision; and providing National with an option and right-of-first refusal on a portion of the property for a period of one year, under the terms and conditions set forth in the amended agreement on file in the office of the City Clerk as Document No. 766941.
