

WHEREAS, The City of San Diego, a municipal corporation, is the owner of a parcel of land in the City of San Diego, ^{JUL 24 1979} County of San Diego, State of California, being a subdivision of Pueblo Lots 1316, 1321 and 1322 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in the year 1870, a copy of said Map being filed in the office of the County Recorder of San Diego County and known as Miscellaneous Map No. 36; and portions of Acre Lot 30 and Acre Lot 32-"C," all in Sorrento Lands and Townsite, in the City of San Diego, County of San Diego, State of California, according to Map thereof Nos. 362 and 483, filed in the office of County Recorder of San Diego County, September 30, 1887 and February 9, 1888, respectively; and

WHEREAS, said City proposes to file a subdivision map of said area to be known as CAMPUS POINT SUBDIVISION; and

WHEREAS, it is necessary for THE CITY OF SAN DIEGO, as a property owner, to consent to the preparation and recordation of a final map thereof; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and City Clerk be, and they are hereby authorized and empowered to execute, for and on behalf of THE CITY OF SAN DIEGO, the certificate of ownership on said final map of CAMPUS POINT SUBDIVISION, consenting to the preparation and recordation of said map.
