BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized to execute an amendment to the contract for the RENTAL OF A LANDFILL COMPACTOR (TANA) from KUHLMAN EQUIPMENT COMPANY which was authorized by Resolution No. 221813, adopted by City Council on September 18, 1978. This amendment will provide for an extension of six (6) months beginning July 1, 1979 through December 31, 1979 on a month to month basis at a price of \$8,000.00 per month; terms net 30 days, plus sales tax with an option to purchase at the end of the six (6) month period for \$107,600.00; terms net 30 days, plus sales tax.
