BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a Grant Deed, the form of which is on file in the office of the City Clerk as Document No. 767001, granting to the SAN DIEGO GAS & ELECTRIC COMPANY an electrical easement and right-of-way, upon, over, under and across portions of Sections 32 and 33 T14S., R2W., S.B.M., as more particularly described in said form of Grant Deed.

BE IT FURTHER RESOLVED, that the City Manager is authorized to accept a quitclaim deed of San Diego Gas & Electric Company executed in favor of The City of San Diego, bearing date of July 12, 1979, quitclaiming San Diego Gas & Electric Company's right title and interest in an existing electrical easement.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, he is hereby authorized and directed to deliver said deeds and a certified copy of this resolution attested by him under seal to be recorded in the office of the San Diego County Recorder.
