WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, that portion of VIA MUNERA has been relocated by the approval on this date of the dedication of a revised alignment for VIA MUNERA by the acceptance of a street easement deed in the subdivision known as LA JOLLA ALTA PRD UNIT NOS. 9 and 10; and

WHEREAS, those properties adjoining that portion of VIA MUNERA to be vacated will continue to have access or will be accessible by the street which has been dedicated with the approval on this date of the street easement deed in the subdivision known as LA JOLLA ALTA PRD UNIT NOS. 9 and 10; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

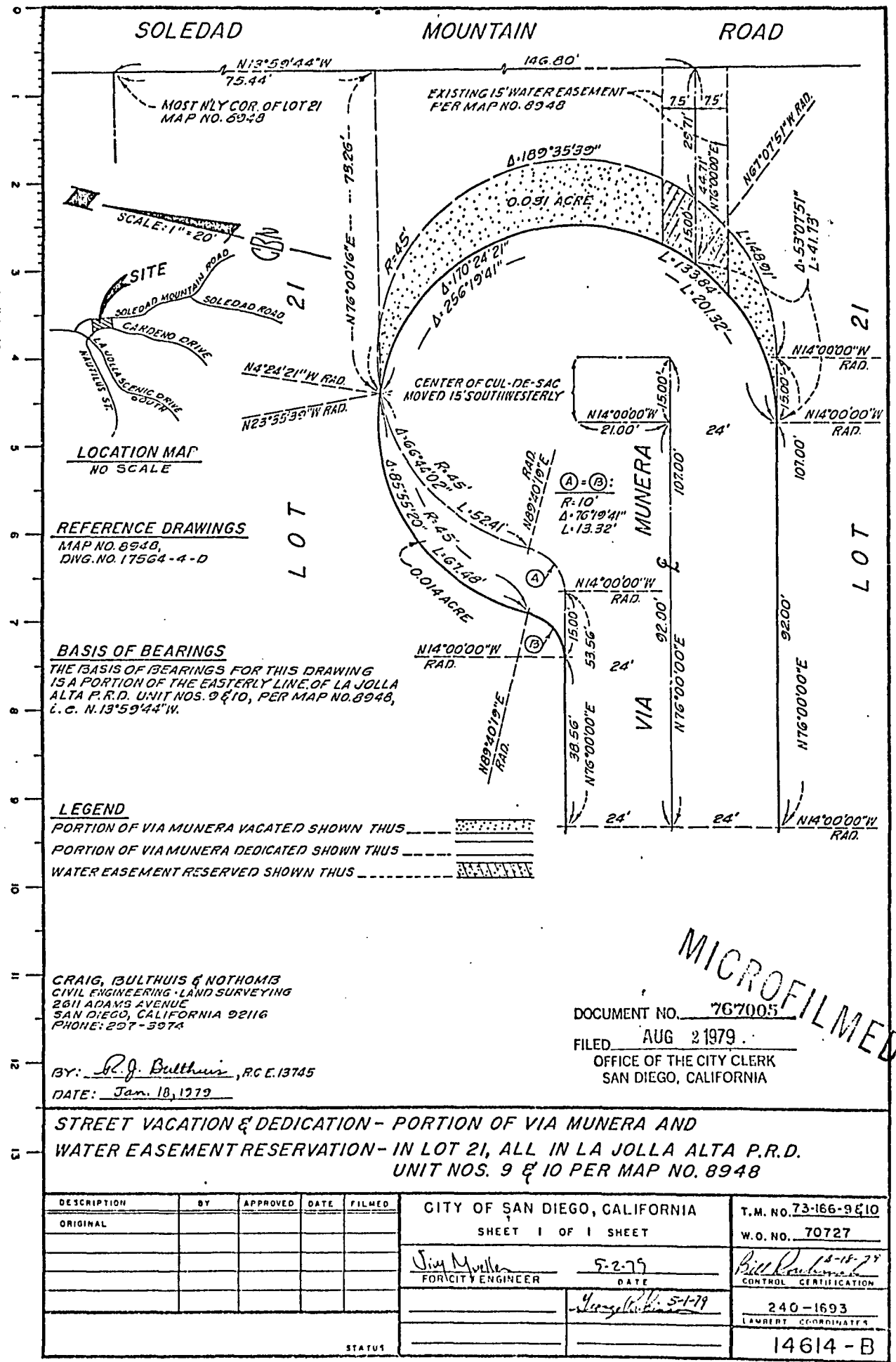



