WHEREAS, LA JOLLA ALTA, a general partnership, has requested  
an exchange of open space easements; and

WHEREAS, the City Manager has certified that the values  
of the property rights to be exchanged are equal; and

WHEREAS, the easements to be acquired will serve the  
same use and purpose as the easements to be quitclaimed by  
the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

1. That the acceptance by the City Manager of that  
deed of LA JOLLA ALTA, a general partnership, executed in favor  
of The City of San Diego, bearing date of April 4, 1979, conveying  
to said City an open space easement in Lot 21 of La Jolla Alta  
PRD Unit Nos. 9 and 10, as more particularly described in said  
deed, is hereby approved.


2. That the Mayor and City Clerk of said City be, and  
they are hereby authorized and empowered to execute, for and  
on behalf of The City of San Diego, a quitclaim deed, a copy  
of which is on file in the office of the City Clerk as Document  
No. 767008, quitclaiming to LA JOLLA ALTA, a  
general partnership, all of the City's right, title and interest  
in the open space easements in lot 21 of La Jolla Alta PRD  
Unit Nos. 9 and 10, as more particularly described in said  
deed.
