BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, UTILITIES AGREEMENT No. 24668 with the STATE DEPARTMENT OF TRANSPORTATION for relocation of water facilities on Interstate 8 between Comino Del Rio overcrossing and 0.1 mile west of Route 15, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. 767031.

BE IT FURTHER RESOLVED, that the expenditure of \$28,525 is hereby authorized out of Water Revenue Fund 502 solely and exclusively to provide funds for the relocation of water facilities and related costs.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$18,761 within Water Revenue Fund 502 from the Unallocated Reserve (69.79) to Annual Allocation Freeway Relocations, CIP No. 73-024 (66.92) for said purpose.
