
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with MCMILLIN DEVELOPMENT, INC., a California corporation, for the purpose of conveying to City fee title to Lot 92 of MC MILLIN SCRIPPS TWO, UNIT NO. 1, under the terms and conditions set forth in that agreement on file in the office of the City Clerk as Document No. 766932.

That the acceptance by the City Manager of that deed of MC MILLIN SCRIPPS TWO, a Joint Venture composed of MLM Development, Inc., a California corporation, and Financial Scene, Inc., a California corporation, executed in favor of The City of San Diego, bearing date of May 3, 1979, conveying to said City Lot 92 of MC MILLIN SCRIPPS TWO, UNIT NO. 1, as more particularly described in said deed, be and the same is hereby approved.

That the City Clerk be, and he is hereby authorized and directed to deliver said deed and a certified copy of this resolution, attested by him under seal, to the Property Department for further handling.
