WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Kenneth C. Bouchard	Water Utilities	\$ 165	Mr. Bouchard is a Senior Utility Supervisor in the Services Division. He suggested that a water service assembly line installation program be initiated. This program increases the productivity of installation crews and is expected to save in excess of \$20,000 annually. This is a partial award pending a final 12-month review
Alvin W. Broyles, Jr.	Water Utilities	\$ 160	Mr. Broyles is a Principal Utility Supervisor in the Services Division. He suggested that PVC pipe be used for temporary highlining of water mains rather than galvanized steel pipe. This saves \$1,596 annually in installation costs.
William V. Nery	General Services	\$ 160	Mr. Nery is an Equipment Mechanic in the Equipment Division. He suggested that relays be removed from the electrical system to reduce maintenance costs. This system has been tested and is expected to save \$3,240 annually. This is a partial award pending a final 12-month review.
Elizabeth L. Deeg	City Clerk	\$ 100	Ms. Deeg is an Intermediate Typist. She suggested that docket items be summarized for quick reference. This suggestion stimulated analysis and development in the area of Council Docket formats which resulted in the development of the Mini-Docket. Substantial savings have been achieved as a result of the Mini-Docket.
