<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Rene A. Duncan	City Clerk	\$ 75	Ms. Duncan was an Intermediate Stenographer at the time of her suggestion. She suggested that a form be used to record the actions taken by the City Council at Council Meetings. This simplifies the procedure for assigning resolution and ordinance numbers and is a significant operational improvement.
Alvin I. Jenkins	Park and Recreation	\$ 75	Mr. Jenkins is a Recreation Facility Caretaker in the Recreation Division. He suggested that vinegar be used as a cleaning agent rather than purchasing all-purpose soap. This is expected to save \$1,991 annually. This is a partial award pending a final 12-month review.
Ronald K. Huber	General Services	\$ 55	Mr. Huber is a Carpenter in the Buildings Division. He developed a method of replacing dutch doors that is both economical and provides better security. Estimated annual savings are \$528.
Alfred D. England	Police	\$ 50	Mr. England is a Sergeant in the Patrol Bureau. He suggested that uprights be added to improve trailer visibility from tow vehicles. This was considered to be a significant safety and operational improvement.
Joseph A. Rametta Riny Snyder Larry Heath John E. Russell	Purchasing	\$ 30	One year ago these Print Shop employees earned an \$80 award for their suggestion to purchase an automatic jogger for collating large printing orders. One year's experience has shown an additional savings of \$280. This is the remainder of their award.
