

RESOLUTION NO. 224137Adopted on JUL 31 1979

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Silas Puentes	Water Utilities	\$ 10	Mr. Puentes is a Utility Supervisor in the Quality Division. He suggested that pop-rivets be used to attach reservoir roofing sheets. This should reduce maintenance costs. This is a partial award pending a final 12-month review.
Charles R. Lyons	Water Utilities	\$ 10	Mr. Lyons is an Equipment Technician II in the Quality Division. He suggested that pesticide be placed in manholes to prevent beehive construction. This was considered to be a significant safety improvement.
Thomas J. Bevers	General Services	\$ 10	Mr. Bevers is an electrician in the Buildings Division. He suggested setscrew style EMT connectors and couplings be provided as a stock item. This saves \$50 annually in installation costs.
John T. Mulvey	Data Processing	\$ 10	Mr. Mulvey is a Junior Clerk. He suggested that a peephole be installed in a rear access door to the Data Processing area in the basement of the City Administration Building. This was considered to be a significant safety improvement.
Valerie S. Smith	Risk Management	\$ 10	Ms. Smith is an Intermediate Typist in the Public Liability Program. She suggested that Utilities Department claims files be color coded for payment processing. This saves \$90 annually in processing costs.
