VACATION OF LA AMATISTA BETWEEN MANGO DRIVE AND
MIRA MONTANA DRIVE.

WHEREAS, it is proposed that La Amatista between Mango Drive and Mira Montana Drive be vacated; and

WHEREAS, there is no present or prospective use for the street either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,



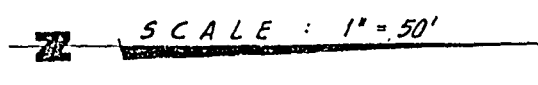
