RESOLUTION CONSIDERING THE PROTESTS, CONFIRMING  
THE ASSESSMENTS FOR THE SAN DIEGO STREET LIGHTING

JULY 1, 1979 THROUGH JUNE 30, 1980; AND AMENDING  
MAPS OF SAID DISTRICT.

WHEREAS, Resolution of Intention No. 223870,  
adopted JUL 2 1979, declared this Council's intention  
to order the confirmation of assessments for the San Diego  
Street Lighting Maintenance District No. 1 for the period of  
July 1, 1979 through June 30, 1980; and

WHEREAS, on the date, time and place set forth in said  
resolution, a public hearing was held with opportunity being  
given to those persons desiring to protest; and

WHEREAS, pursuant to Chapter VI, Article 5, Division 2,  
Sections 65.0201 through 65.0222 of the San Diego Municipal  
Code, the Council has considered and reviewed the costs to be  
assessed for the supplying of energy, maintenance and service  
for the ensuing year; and

WHEREAS, the proposed assessments for the said maintenance  
district are on file in the office of the Street Superintendent  
and have been made available for public inspection; NOW,  
THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

The assessments described in said Resolution of Intention No. 223870 and on file in the office of the Street Superintendent of The City of San Diego Street Lighting Maintenance District No. 1 for the period of July 1, 1979 through June 30, 1980, are hereby confirmed and approved as the amounts to be assessed to the individual properties within the lighting district.
3. The amended maps of said district be approved to show the consolidations, splits and the dissolutions as shown on the amended maps of said district on file in the office of the City Clerk as Document No. 766722.
