WHEREAS, A. H. and Janet Stoddard have filed a claim with The City of San Diego for property damage which occurred to their property in the amount of \$6,849.00, and


WHEREAS, the amount of \$4,500.00 was advanced to begin repairs on the Stoddard residence; NOW, THEREFORE,
