WHEREAS, the City Council has reviewed the Tia Juana River Valley Plan Local Coastal Program Addendum as prepared in compliance with the specific conditions imposed upon approval of the plan by the San Diego Coast Regional Commission; and

WHEREAS, the Tia Juana River Valley Plan Local Coastal Program Addendum provides for the conservation of a 20-30-acre riparian habitat area east of Dairy Mart Road and recognizes that the preservation option rather than relocation of this area is considered to be more desirable to assure consistency with Sections 30231, 30233 and 30240 of the Coastal Act; and

WHEREAS, the Tia Juana River Valley Plan Coastal Program Addendum does propose a comprehensive evaluation of the possibility of relocation of the habitat area east of Dairy Mart Road; and

WHEREAS, the City Council also recognizes the very important goal of broadening employment opportunities in the San Ysidro and Tia Juana River Valley Plan areas to provide employment for residents in close proximity to their homes; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council strongly favors meeting Coastal Act requirements through relocation of the existing habitat areas in the vicinity of Dairy Mart Road so that the area may be utilized to enhance the economic base of South Bay Communities in accordance with Council Policy 900-1.


