That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with PURCELL & RULE, Architects, to provide professional services for Fire Station No. 40, Los Penasquitos, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. 767132.

BE IT FURTHER RESOLVED, that the expenditure of \$62,700 from Capital Outlay Fund 30245 of The City of San Diego, be hereby authorized, solely and exclusively, for the above-stated purpose and related project costs.

BE IT FURTHER RESOLVED, that it be and it is hereby certified that the information contained in the Environmental Negative Declaration on file in the office of the City Clerk as EQD No. 79-02-43 has been completed in compliance with the California Environmental Quality Act of 1970 and the State guidelines pursuant thereto, and that said Environmental Negative Declaration has been reviewed and considered by this Council.




CERTIFICATION OF UNENCUMBERED BALANCE
