Frank O. Lovett	Park and Recreation	\$ 120	Mr. Lovett is a Carpenter in the Aquatics Division. One year ago he earned a \$120 award for his suggestion to fabricate wooden lifeguard buoys rather than purchase fiberglass buoys. An additional \$1,190 in savings has been identified after one year's use. This is the remainder of his award.
Thomas B. Wells	General Services	\$ 100	Mr. Wells is a Carpenter in the Buildings Division. He suggested that one person carpenter crews be used to perform work. This is being done as much as possible dependent upon equipment availability and the nature and safety of the work. Although savings are difficult to calculate, this is a significant productivity improvement.
Barbara J. Singley	City Clerk	\$ 100	Ms. Singley is a Senior Typist. She suggested that companies be charged for the publication of an ordinance that grants them a franchise. To date, this has saved the City \$995 in publication costs.
