

RESOLUTION NO. 224192 (R.79-2262) **AUG 7 1979**

VACATION OF THE SOUTHERLY 17 FEET OF BELLINGHAM AVENUE AND WESTERLY 30 FEET OF 37TH STREET ADJACENT TO LOT 16 OF BLOCK 119 OF MAP 1007.

WHEREAS, it is proposed that the Southerly 17 feet of Bellingham Avenue and the Westerly 30 feet of 37th Street adjacent to Lot 16 of Block 119 of Map 1007 be vacated; and

WHEREAS, there is no present or prospective use for the street either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California that the Southerly 17 feet of Bellingham Avenue and the Westerly 30 feet of 37th Street adjacent to Lot 16 of Block 119 of Map 1007 as more particularly referred to in Resolution of Intention No. 223733, is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that the Southerly 17 feet of Bellingham Avenue and the Westerly 30 feet of 37th Street adjacent to Lot 16 of Block 119 of Map 1007, as more particularly shown on Drawing No. 14572-B on file in the office of the City Clerk

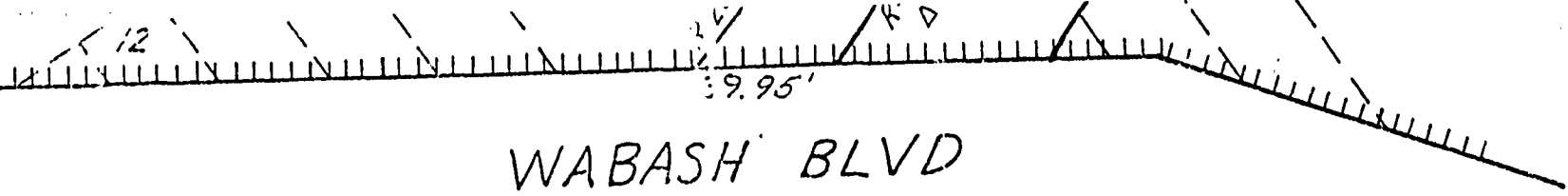

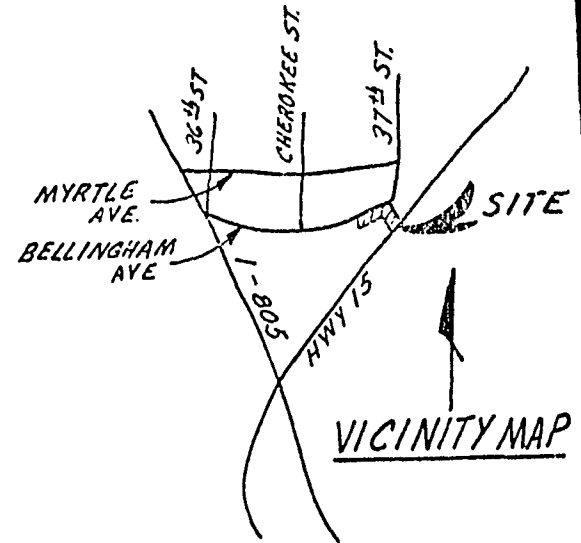
