That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Kenneth J. Hannibal	Fire	\$ 20	Mr. Hannibal is an Engineer. He suggested that rescue tools be color coded by size. This is expected to reduce confusion and is considered to be a significant safety and operational improvement.
David A. Pruitt	Fire	\$ 20	Mr. Pruitt is an Equipment Repair Supervisor. One year ago he earned a \$100 award for his suggestion to use wooden blocks to brake vehicles while brake drums cool. One year's experience has shown a total savings of \$1,188. This is the remainder of his award.
John T. Mulvey	Data Processing	\$ 10	Mr. Mulvey is a Junior Clerk. He suggested that motorcycle parking stalls be equipped with locking devices. This is expected to improve public relations and aid enforcement.
Delorese J. Shafer	Risk Management	\$ 10	Ms. Shafer is an Intermediate Typist. She suggested that two forms used to track LWOP employees be combined. This is expected to save \$78 annually in printing and processing costs.
Margaret A. Thomas	Risk Management	\$ 10	Ms. Thomas is a Senior Typist. One year ago she earned an award for her idea to revise Safety Training Certificates. One year's experience has shown a savings of \$299. This is the remainder of her award.
