Jeryl K. Copp	Treasurer	\$ 10	Ms. Copp is an Intermediate Clerk. She suggested that the Utilities "Notice of Check Return" be revised to include a statement of type of payment accepted. This is expected to improve public relations.
John T. Mulvey	Data Processing	\$ 10	Mr. Mulvey is a Junior Clerk. He suggested that the location of shelf tape identifiers be changed. This was considered to be a significant operational improvement.
