APPROVING MAP OF HAL-SPECTRUM

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by M. KENT JOHNSON, a Registered Civil Engineer, entitled "HAL-SPECTRUM Being a subdivision of Lots 44 and 45 and portions of Lots 46, 49 and 50 of Block S and Lot 42 of Block R of Montclair according to the Map thereof No. 1684 filed in the office of the County Recorder of San Diego County March 20, 1916, together with Haller Street (formerly Jefferson Avenue) and a portion of Wabash Avenue adjacent to Estrella Park shown on the amended map of City Heights according to the Map thereof No. 1007 filed in the office of said County Recorder October 3, 1906 as closed and vacated to public use and also together with Haller Street (formerly Jefferson Avenue) and portions of Wabash Avenue and the alley as dedicated to public use all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Haller Street for public purposes, and said street is hereby declared to be a public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
