WHEREAS, SAN DIEGO UNIFIED PORT DISTRICT, a public corporation, has requested an exchange of water easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easements to be acquired will serve the same use and purpose as the easements to be quitclaimed by the City; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the acceptance by the City Manager of that deed of SAN DIEGO UNIFIED PORT DISTRICT, a public corporation, executed in favor of The City of San Diego, bearing date of July 31, 1979, conveying to said City a water easement in San Diego Unified Port District Lands (Tidelands), as more particularly described in said deed, is hereby approved.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 250073-2, quitclaiming to San Diego Unified Port District, a public corporation, all of the City's right, title and interest in the water easements in San Diego Unified Port District Lands (Tidelands), as more particularly described in said deed.

3. That the City Clerk of said City is hereby authorized and directed to deliver said easement and quitclaim deeds, and a certified copy of this resolution to the Engineering and Development Department for further handling.
