APPROVING MAP OF CLAIREMONT MESA SPECIALTY CENTER

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by SAMUEL F. SAFINO, a Registered Civil Engineer, entitled "CLAIREMONT MESA SPECIALTY CENTER Being a subdivision of a portion of Pueblo Lot 1233 of the Pueblo Lands of San Diego in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which said Map was filed in the office of the County Recorder of San Diego County, and known as Miscellaneous Map No. 36.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public a portion of Clairemont Mesa Boulevard and the unnamed alley for public purposes; and said portion of a street and unnamed alley are hereby declared to be a portion of a public street and public unnamed alley and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.


