OF SAN DIEGO APPROVING THE APPLICATION FOR
COASTAL CONSERVANCY GRANT FUNDING FOR ACCESS
RECONSTRUCTION AT THE CHILDREN'S POOL IN
LA JOLLA.

WHEREAS, the Legislature, under Assembly Bill 3544 (Public Resources Code 31000-31405) has established the Coastal Conservancy and authorized it to amend grants to local public agencies for acquisition of coastal land and planning of projects of such land; and

WHEREAS, the grants are awarded pursuant to rules established by the Coastal Conservancy for determination of project eligibility for funds; and

WHEREAS, said applications contain assurances with which the applicant must comply; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to:

1. File an application for Coastal Conservancy assistance for the access reconstruction at the Children's Pool in La Jolla and to execute all documents necessary for funding said project.

2. Certify that said City understands the assurances in the application as set forth in Document No. RR-250086 which is on file in the office of the City Clerk.
