WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Harry J. Keehan	Library	\$ 50	Mr. Keehan is a Library Assistant. He suggested that an automatic dialing system be acquired for the Directory Desk. This reduces busy lines to the public. Savings are difficult to estimate, but this was considered to be a significant public service improvement.
David R. English	Police	\$ 65	Mr. English is a Police Officer. He suggested that one copy of the Hit and Run Accident Reports be eliminated. This saves \$636 annually in copying and labor costs.
Michael E. Bock	Utilities	\$ 55	Mr. Bock is a Principal Clerk in the Administration and Services Division. He suggested that the receipt form be revised to allow multiple entries. This saves \$552 annually in material and labor costs.
Bradley H. Brown	Fire	\$ 50	Mr. Brown is a Fire Fighter. He suggested that fire incident forms be combined. This is expected to save \$934 annually in material costs. This is a partial award pending a final 12-month review.
Lee R. Noorda	Property	\$ 50	Mr. Noorda is an Electrician at San Diego Stadium. He suggested that eyebrow lights be replaced with less expensive equipment. This is expected to save \$1,000 annually in replacement costs. This is a partial award pending a final 12-month review.
