That the following suggestion awards are hereby approved and the Auditor and Comptroller i hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Danny A. Lewis	Engineering and Development	\$ 40	Mr. Lewis is an Intermediate Typist in the Field Engineering Section. One year ago he earned a \$35 partial award for his suggestion to use a stamp to track field contractors' affirmative action forms. One year's experience has shown a total savings of \$732. This is the remainder of his award.
Marian L. Lake	Housing Authority	\$ 35	Ms. Lake is an Intermediate Clerk. She suggested that prospective tenants return their inspection booklets at the time of final processing. This is expected to save \$365 annually in material and processing costs.
Phillip J. Love	General Services	\$ 25	Mr. Love is a Carpenter Supervisor in the Buildings Division. He suggested that Form PW-999 be revised to provide the exact location of work to be done. Savings are expected to be substantial. This is a partial award pending a final 12-month review.
Patricia L. Page	Utilities	\$ 20	Ms. Page is a Senior Clerk in the Administration and Services Division. She suggested that a form be designed for transportation authorizations. This is expected to save \$220 annually in processing time.
Lee R. Noorda	Property	\$ 20	Mr. Noorda is an Electrician at San Diego Stadium. He suggested that broken ticket windows be replaced with lexan plastic. This was considered to be a significant safety improvement.
