<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Leslie M. Nuhn	Police	\$ 20	Mr. Nuhn is a Police Agent. He suggested that Form PD-19 be revised to reduce processing time. Estimated first year's savings are \$183.
Rudi L. Southerland	Park and Recreation	\$ 15	Mr. Southerland is a Life-guard II. He suggested that scrap material be used to make boat bumpers. Estimated first year's savings are \$171.
Myrna F. Choate	Risk Management	\$ 10	Ms. Choate is an Administrative Aide II in the Group Health and Life Insurance Program. One year ago she earned a partial award for her suggestion to reduce the copying costs required to process suggestions. One year's experience has shown a total savings of \$236. This is the remainder of her award.
Guthrie Riley	General Services	\$ 10	Mr. Riley is an Assistant Airport Supervisor. He suggested that the Brown Field crash grid be utilized by Firefighters in locating brush fires. Although the Fire Department will be using their own grid system, they are utilizing an aerial photograph of Brown Field. This was considered to be a significant operational improvement.
