
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to, subject to and in accordance with the City's established policies, contract with appraisers and surveyors to establish actual boundaries and values for the following properties in order to determine whether to acquire such properties for open space park purposes:

- a) The Kaiser property in Priority Area #2 of the Lake Murray-Cowles-Fortuna Regional Park.
- b) 10.5 acres in the Glen Canyon area of the Chollas-Radio Canyon open space system.
- (c) 36 acres adjacent to Highway 94 on the south side, north of Kelton in the Chollas-Radio Canyon.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$80,000 from Land Acquisition Fund 79101 for such survey and appraisal services is hereby authorized and approved.


