

RESOLUTION No. R-250106 (R-80-2231)

Adopted on AUG 22 1980

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That in connection with the designation of portions of the Chollas-Radio Canyon as open space, that property owned by Mrs. Montgomery shown as portions of Lots 7, 8 and 9 on the open space map, is hereby directed to be deleted.

BE IT FURTHER RESOLVED, that the City hereby expresses its intent that no private property which has been developed will be acquired for open space other than property which is located in the streambed of the creek which passes through the canyon together with any necessary access path along the streambed.

BE IT FURTHER RESOLVED, that those general boundaries for an open space system in the area of Chollas-Radio Canyon, as shown on that map on file at the Open Space Division of the Park and Recreation Department, is hereby approved.

BE IT FURTHER RESOLVED, that the boundaries hereby approved are established for planning purposes and may be amended from time to time by future City Council resolutions, and persons owning property within said boundaries are not precluded in any way by this action from utilizing or developing their properties consistent with the existing zoning and other City land use ordinances.
