WHEREAS, a sewer easement was acquired for an earlier proposed development in the area of the subdivision of SMOKE TREE ADOBE FALLS; and

WHEREAS, the present development of the property requires realignment of the existing easement; and

WHEREAS, the aforementioned easement no longer serves the purpose for which it was originally acquired; and

WHEREAS, the City will receive substitute easements where required as granted on the map of the subdivision known as SMOKE TREE ADOBE FALLS; and


WHEREAS, the City has no present or prospective use for the easement and the City Manager has recommended that the City abandon its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City of San Diego, by this resolution, does hereby abandon whatever right, title or interest it may have in the sewer easement, as more particularly shown on Drawing No. 14821-B on file in the office of the City Clerk as Document No. RR250115-A which is by this reference incorporated herein and made a part hereof.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
