

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the Resolution No. 222358 adopted on December 11, 1978 for the EXTENSION OF STORM DRAIN SOUTH OF OAKRIDGE ROAD BETWEEN STRATUS COURT AND CIBOLA ROAD (STORM DAMAGE REPAIR) in the City of San Diego, California is hereby rescinded.
2. That the Bid of \$89,469.00 by Viewland Investment Co., Inc. dba Viewland Construction Co., a corporation for the EXTENSION OF STORM DRAIN SOUTH OF OAKRIDGE ROAD BETWEEN STRATUS COURT AND CIBOLA ROAD (STORM DAMAGE REPAIR) in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 766423.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$121,500.00 from the Disaster Assistance Fund 39024 to CIP 11-171.
4. That the expenditure of \$121,500.00 is hereby authorized out of the Disaster Assistance Fund 39024 of the City of San Diego solely and exclusively for providing funds for said project and related costs.
