3. That the expenditure of \$23,947.23 from Transient Occupancy Tax Fund 10223 and \$396.73 from Convention and Performing Arts Center Operating Fund 10320 for CIP #34-0280, Civic Theatre: Replacement of Curtains is hereby authorized.


