APPROVING MAP OF LOMA AIRE UNIT NO. 2

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by G. B. PHILLIPS, a Registered Civil Engineer, entitled "LOMA AIRE UNIT NO. 2 Being a subdivision of a portion of Parcel 3 of Parcel Map No. 4381, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder January 9, 1976.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Shirmarlin Way, Tingley Way and a portion of Canon Street for public purposes, and said streets and portion of a street are hereby declared to be public streets and a portion of a public street and dedicated to the public use.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Canon Street, adjacent and contiguous to Lots 1 through 7 and Lots 12 and 14, all as shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of a public street are accepted on behalf of the public as heretofore stated; and that the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
