That the petition for the improvement of the ALLEY, BLOCK 33, LEXINGTON PARK (between Violet Street, Pepper Drive & Azalea Park), under the provisions of the Improvement Act of 1911, consisting of two sheets and filed under Document No.. D-02195-1 is hereby granted.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of the ALLEY, BLOCK 33, LEXINGTON PARK (between Violet Street, Pepper Drive & Azalea Park) in the City of San Diego, by grading and paving it as an alley section, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvements hereinabove mentioned.
