

That the acceptance by the City Manager of that Street Easement Deed of CHARLES M. DICK and JOSEPH F. RAMUNO, as tenants in common, executed in favor of The City of San Diego, bearing date of May 29, 1979, conveying to said City an easement for public street purposes over, along, and across the Northerly 10 feet of Lots 3, 4 and 5 of the resubdivision of a portion of Rosemont Addition to Encanto Heights, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named RADIO DRIVE.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and empowered to deliver said deed and a certified copy of this resolution, attested by him under seal, to the Engineering and Development Department for further handling.
