
Adopted on SEP 10 1979

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the conversion of traffic signal and street lighting services, installation of new luminaires and new electroliers as needed on Aero Drive from Afton Road to Convoy Street, Kearny Mesa Road from Convoy Street to Othello Avenue, and on Convoy Street from Aero Drive to Othello Avenue, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.

BE IT FURTHER RESOLVED, that the expenditure of \$21,000 is hereby authorized from Capital Outlay Fund 245 (CIP 37-028, Undergrounding City Utilities) for the sole and exclusive purpose of providing funds for the above work and related costs.


