
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in converting the traffic signal and street lighting services, and installing new luminaires and new electroliers as needed on University Avenue between Third Avenue and Center Street, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.

BE IT FURTHER RESOLVED, that the expenditure of \$18,500 is hereby authorized from Capital Outlay Fund 245 (CIP 37-028, Undergrounding of City Utilities) for the sole and exclusive purpose of providing funds for executing this work and related costs.




