as follows:



A. Bush Addition, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1915, filed in the office of the County Recorder of San Diego County, June 4, 1926.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.
