
BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, a Registered Civil Engineer, entitled "MISSION KNOLLS Being a subdivision of Lot 1 of Rhodesia, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 5474, filed in the office of the County Recorder of San Diego County, October 7, 1964, except therefrom all minerals, coals, oils, petroleum, gas and kindred substances in and from said land, all such operations to be conducted only below a depth of 200 feet below the surface thereof in and to that portion of said land formerly lying within Lot 2677 of Allied Gardens Unit No. 15, according to Map thereof No. 3873.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
