Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, a Registered Civil Engineer, entitled PLUM TREE CONDOMINIUMS Being a subdiviion of Lot 1893 of Mission Village Unit No. 22, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 5709 filed in the office of the Recorder of said County, April 8, 1966, except therefrom all oil, gas, mineral and hydrocarbon rights and substances in and under the land but beneath a plane 500 feet below the surface of the land but without any right of surface entry, as reserved by Mary Georgie Ames Wright, a married woman, in deed recorded October 18, 1956, as Document No. 146958 in Book 6305, Page 30 of Official Records., " is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.
