

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$2,178,400 from the Industrial Development Fund 30248 to the Capital Outlay Fund 30245; and \$2,178,400 of sales tax revenue is hereby allocated for transfer to the Redevelopment Agency Fund 10227.

BE IT FURTHER RESOLVED, that the transfer of said \$2,178,400 to the Redevelopment Agency from Fund 10227 is hereby authorized and approved.




