BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue a warrant check in the amount of \$35,000.00 made payable to COUNTY CLERK ON BEHALF OF JESSIE JAMES LUFFMAN, AN INCOMPETENT PERSON, in full settlement of the lawsuit and of all claims.


