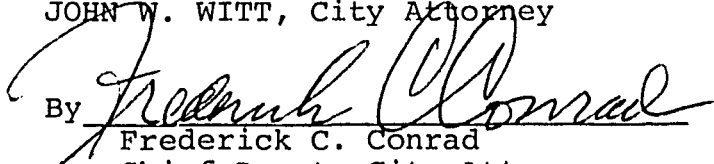
BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, a Registered Civil Engineer, entitled "KANTOR VIEW Being a subdivision of that portion of Lot 31 of the partition of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to partition map thereof made in Superior Court Case No. 348 entitled "Juan M. Luco, et al vs. Commercial Bank of San Diego," filed January 14, 1886 in the office of the County Clerk of said County, as conveyed to the State of California in Parcel 4 of Final Order of Condemnation recorded April 17, 1969 as Instrument No. 66824 of Official Records of said County, lying southerly of the southerly right of way line of State Freeway 11-SD-8-4.8.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
