## RESOLUTION NO. R-250218 APPROVING MAP OF SKYLINE VILLAS

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, a Registered Civil Engineer, entitled "SKYLINE VILLAS Being a subdivision of a portion of the East Half of Lot 11 of Cave and McHatton Subdivision, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 159, filed in the office of the County Recorder of San Diego County, March 30, 1887.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public Ozzie Way and Harps Court for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
