

RESOLUTION NO. R-250229 (R. 80-529)

WHEREAS, the City Council has in Resolution No. 250180 declared that certain weeds, rubbish, refuse and dirt existing on private property more particularly described in said resolution constitute a public nuisance; and

WHEREAS, the Council has in said resolution declared its intention to order the abatement of same; and

WHEREAS, the hearings provided for in said resolution for the consideration by the Council of factual showing by affected property owners why said nuisance should not be abated and any and all objections to the proposed removal of weeds, refuse, rubbish and dirt have been held and concluded as provided for in said resolution; and

WHEREAS, at said hearings all persons desiring to be heard were fully heard and all oral and written protests and objections, if any, were fully considered, and this Council gave all persons present an opportunity to hear and be heard in respect to the proposed abatement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that each and every oral and written protest and objection, if any, made or filed in the matter of the proposed removal of weeds, refuse, rubbish and dirt is hereby overruled and denied except for those, if any, more particularly described in Exhibit A attached hereto and incorporated herein, which were allowed.
