1. That the City Auditor and Comptroller is hereby authorized to transfer \$25,000.00 from the Special Unallocated Reserve to fund the cost of removal of weeds, rubbish, refuse and dirt from certain streets, sidewalks and private property in the City of San Diego.
2. That the bid of ROWE WEED ABATEMENT is hereby accepted and the City Manager is hereby authorized to execute a contract to perform WEED AND LITTER ABATEMENT as may be required for a period of two (2) months beginning October 1, 1979 through November 30, 1979 in accordance with prices on file in the City's Purchasing Department.


