

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with SAN DIEGO KIND CORPORATION, for the purpose of accomplishing off-site improvements and payment of fees required in the construction of San Diego Square, a HUD subsidized low-cost housing project located at 10th Avenue and "C" Street, under the terms and conditions set forth in that agreement on file in the office of the City Clerk as Document No. RR-250234.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$102,226 from the 1979 Community Development Block Grant Contingency Reserve Fund No. 18515, for said purpose and related costs, is hereby authorized and approved.
