

RESOLUTION NO. R-250241Adopted on SEP 18 1979

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
John L. Groff	Utilities	\$165	Mr. Groff is an Assistant Civil Engineer in the Systems Division. He suggested that weekend readings of lake gauges be eliminated. This has resulted in an annual savings of \$1,657.
Charles R. Sims	Utilities	\$100	Mr. Sims is a Plant Operator in the Quality Division. He suggested that underwater lights be installed in mixing and settling basins to provide a visual estimate of the result of adding chemicals to the water. Savings are extremely difficult to calculate, but this provides an added measure of quality control.
George R. Ikeda	General Services	\$100	Mr. Ikeda is a Carpenter in the Buildings Division. He suggested that particle board be used in the fabrication of cabinets rather than plywood. This is expected to save \$2,000 in the first year of operation. This is a partial award pending a final 12-month review.
