

RESOLUTION NO. R- 250257

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That the City Council urges the U.S. Army Corps of Engineers to act fully and promptly to provide adequate flood protection along Las Chollas Creek including, but not limited to, the realignment and improvement of Chollas Creek in the Southcrest West Development Plan.

BE IT FURTHER RESOLVED, that the City Council urges the congressional delegation to actively assist the City in securing the aforementioned improvements.

BE IT FURTHER RESOLVED, that the City Council directs the City Manager to cause the complete and immediate improvements of South Las Chollas Creek Flood Control Project Phases II and III and authorizes the advancement of necessary City funds for design.

BE IT FURTHER RESOLVED, that the City Manager is directed to thoroughly review the existing flood dangers along South Las Chollas Creek between Imperial Avenue and Oceanview Boulevard to insure that the proposed improvements will be sufficient to contain extremely heavy water flow near Oceanview Boulevard and San Pasqual.

BE IT FURTHER RESOLVED, that the City Manager review the existing flood dangers along Las Chollas Creek east of I-805 and west of Market Street to eliminate flooding of adjacent property, and make recommendations to the Council regarding

necessary improvements, including funding sources, by December 1, 1979.

BE IT FURTHER RESOLVED, that the City Manager provide interim measures where needed to reduce the impact of future flooding along Las Chollas Creek, including:

(1) Inspecting the existing streambed for problem areas and debris clearance prior and during storm season;

(2) Providing communication to concerned citizens regarding availability, coverage and costs of subsidized flood insurance under the National Flood Insurance Program;


(3) Providing information to concerned citizens regarding flood proofing measures they can apply on their own; and

(4) Identifying potential hazardous drainage and flood control facilities and take appropriate action to enhance public safety.

BE IT FURTHER RESOLVED, that relative to those locations which may not be within the jurisdiction of the City of San Diego which impact property within the City of San Diego, the City Manager is directed to request the appropriate entity to take prompt and full action to eliminate potential danger.

BE IT FURTHER RESOLVED, that the City Manager provide regular progress reports to the Council outlining the actions taken on each of the aforementioned concerns.
